



PARENT CONTRACT

I, _____, understand that Tolbert Preparatory Academy is a public school. I understand that the following efforts will be part of my responsibilities as a parent/guardian of Tolbert Preparatory Academy student. Therefore, I agree to the following requirements in order to be eligible to re-enroll:

- 1) I agree to participate and abide by the rules set forth in the Parent/Student Handbook.
- 2) As a parent/guardian of a student(s) of Tolbert Preparatory Academy, I will:
 - a) Help my child establish regular attendance and punctuality. (Children with irregular attendance, including frequent tardies, will not be guaranteed a spot for the next school year). See Parent/Student Handbook
 - b) Attend school activities, meetings, parent-teacher conferences, mandatory Parent Meetings, and all pertinent school functions.
 - c) Pay donations and classroom fees by the prescribed time.
 - d) Follow through and see that my child does his or her homework assignments nightly.
 - e) Cooperate with Parent Board projects and functions directed toward assisting the school, assist with and participate in school fundraisers.
- 3) I will monitor my child's academic performance and agree that:
 - a) Instructors will identify students not meeting the requirements for promotion during the first grade card marking period.
 - b) A conference will be held with the administration, instructor(s), and parents to discuss the academic concerns.
 - c) Collaboratively, a plan will be devised for the student with the understanding that the parent will work along with the school to bring the child's performance to a satisfactory level.
 - d) Methods will vary including tutoring, mentoring peer tutoring, Saturday School and alternate methods of evaluation.
 - e) As a parent/guardian of a student of Tolbert Preparatory Academy, if Saturday School becomes a need for my child, he/she will attend.
- 4) As a parent/guardian of a student of Tolbert Preparatory Academy, I agree to purchase the uniform required for my child's grade level. See Parent/Student Handbook for grade level uniform requirements.
- 5) Fundraisers: In an effort to offset expenses for activities and supplies, I agree to support any fundraising activities. I agree to participate and sell \$200 (profit) per family for the combined fall and spring fundraisers.
- 6) Fundraiser Fee: I understand that in lieu of doing the fall and spring fundraisers, I may donate \$200 to the school. The donation will be paid the first day of the 2nd quarter or I will be expected to participate in the above-mentioned fundraiser.
- 7) I will also agree to support the community building events that are part of the school.
- 8) I agree to participate in the school's Parent Work Service Program with an annual minimum of 20 volunteer work hours.

I understand that failure to meet the above expectations will cause me to forfeit early enrollment opportunities.
